About this award summary

This WA award summary is a summary of the state Cleaners and Caretakers (Car and Caravan Parks) Award and does not include all obligations required by the award. It is important that you also refer to the full Cleaners and Caretakers (Car and Caravan Parks) Award that is available on the WA Industrial Relations Commission website www.wairc.wa.gov.au

Provisions of other employment legislation also apply to employees and have been included in this WA award summary where appropriate. You may need to refer to the *Minimum Conditions of Employment Act 1993*, the *Long Service Leave Act 1958*, and the *Industrial Relations Act 1979* for full details.

The 2020 State Wage Order issued by the WAIRC in June 2020 granted an increase in pay rates under this award effective from the first pay period on or after 1 January 2021.





Three Step Check: to make sure this WA award summary is relevant to you

Step 1

Is the business in the state system?

This WA award summary applies to businesses in the **state industrial relations system.** It covers businesses which operate as:

- ✓ **sole traders** (e.g. Jane Smith trading as Jane's Caravan Park)
- unincorporated partnerships (e.g. Jane and Bob Smith trading as Jane's Caravan Park)
- unincorporated trust arrangements (e.g. Jane and Bob Smith as trustees for Jane's Caravan Park)
- incorporated associations and other non-profit bodies that are not trading or financial corporations

This summary does **not** apply to businesses in the national industrial relations system which operate as:

- Pty Ltd businesses (e.g. Smith Pty Ltd trading as Jane's Caravan Park)
- incorporated partnerships or incorporated trusts
- Incorporated associations and other non-profit bodies that are trading or financial corporations

Step 2

Is the business covered by the Cleaners and Caretakers (Car and Caravan Parks) Award?

The Cleaners and Caretakers (Car and Caravan Parks) Award applies to businesses in the state industrial relations system which are:

- caravan parks
- ✓ car parks

Step 3

Is the employee's job covered by the Cleaners and Caretakers (Car and Caravan Parks) Award? The Cleaners and Caretakers (Car and Caravan Parks) Award sets pay rates, working hours and other employment arrangements for employees working

as:

- caretakers
- ✓ cleaners
- ✓ parking attendants
- ✓ watchpersons



Employers covered by this WA award are legally required to keep employment records. Employers can be fined up to \$5,000 for not keeping employment records, for keeping inadequate or fraudulent records, or for not providing records to Industrial Inspectors when required to do so. Page 6 details record keeping requirements.

The Cleaners and Caretakers (Car and Caravan Parks) Award is a legal document that outlines the minimum wages and condition of employment that must be provided to employees who are covered by the award. Employers and employees cannot agree to lesser conditions.

Industrial Inspectors at the Department of Mines, Industry Regulation and Safety have statutory powers to investigate employee complaints about underpayment of wages or leave entitlements under this WA award and state employment laws. The department can prosecute employers in the Industrial Magistrates Court for not paying the rates of pay, including overtime, penalty rates and allowances required by this WA award.

All rates of pay are gross rates (before tax). The 2020 State Wage Order increased pay rates effective from the first pay period on or after **1 January 2021**. The tables below provide the rates that apply from the first pay period on or after **1 January 2021**.

Junior rates of pay

Junior employees receive a percentage of the minimum rate for the appropriate classification of work:

Age	% of adult
20 years of age	90%
19 years of age	80%
18 years of age	70%
17 years of age	60%
16 or 15 years of age	50%

• Under the *Children and Community Services Act 2004*, it is illegal to employ children under the age of 15 in this industry, except if the child is working as part of a school program or in a family business.

Registered trainees

- Registered trainees are employees who are undertaking a traineeship registered with the <u>Apprenticeship Office</u> at the Department of Training and Workforce Development. Traineeships can be undertaken on a full time or part time basis.
- Registered trainees under the Cleaners and Caretakers (Car and Caravan Parks) Award must be paid the same minimum salaries that apply to other employees working under the award, according to age and the appropriate classification level. Registered trainees are covered by all other provisions of the award, including working hours, penalty rates, allowances and leave entitlements.
- An employer is required to pay a registered trainee for time spent at TAFE (or other off the job training) as normal working hours. An employer is not required to pay TAFE fees on behalf of the registered trainee.

pployment of children

- Under the Children and Community Services Act 2004, it is illegal to employ children under the age of 15 in this
 industry, except if the child is working as part of a school program (e.g. work experience placement) or in a family
 business.
- School aged children must not be employed during school hours, unless participating in a school program.

Meal money

An employee, required to work overtime for two or more hours, must be supplied with a meal by the employer or be paid \$9.05 for a meal and, if owing to the amount of overtime worked, a second or subsequent meal is required the employee must be supplied with such meal or paid \$6.20 for each meal so required.

Meal money provisions do not apply:

- if the employee was notified the previous day or earlier that he/she is required to work overtime or
- if the employee lives in the same locality as their place of work and can reasonably go home for a meal.

Leading hand allowance

If an employee is placed in charge of other employees, they must be paid the following allowance in addition to their weekly wage:

•	If in charge of between 3 and 6 staff	\$14.20
•	If in charge of between 7 and 10 staff	\$25.30
•	If in charge of between 11 and 15 staff	\$31.60
•	If in charge of between 16 and 20 staff	\$38.40
•	If in charge of more than 20 staff	\$49.30

Broken shift allowance

If an employee is required to work their ordinary hours of duty per day in more than one shift and the break between shifts is three hours or more they must be paid \$3.15 per day.

Toilet cleaning allowance

If an employee is required to clean closets (toilets), they must be paid the following allowance in addition to their weekly wage.

•	5 or more closets but less than 10 closets per day*	\$4.40
•	10 or more closets but less than 30 closets per day*	\$13.10
•	30 or more closets but less than 50 closets per day*	\$26.10
•	50 or more closets or greater per day*	\$32.70

^{*} One metre of urinal counts as one closet and three urinal stalls counts as one closet.

Motor vehicle allowance

If an employee is required and authorised to use their own vehicle in the course of their duties they must be paid a motor vehicle allowance. Allowance rates are available in the Cleaners and Caretakers (Car and Caravan Parks) Award on the WA Industrial Relations Commission website www.wairc.wa.gov.au or by contacting Wageline.

Location allowance for employees in regional areas

- Employees employed in certain regional towns must be paid the location allowance relevant to that town. Rates
 listed below are for adult employees working full time. Junior employees, casual employees, part time employees,
 apprentices and trainees must be paid proportionate location allowance based on the proportion which their
 weekly wage is to the adult rate under the WA award.
- If an employee has a dependant (a spouse or partner, or a child if there is no spouse or partner) the employee is entitled to receive double the allowance specified for the relevant town except if the dependant also receives a location or district allowance payment as part of their own employment.
- If an employee has a 'partial dependant' (a dependant who receives a district or location allowance of their own which is less than the location allowance the employee is entitled to under this award) the employee is entitled to receive:
 - o the relevant location allowance for the employee's town; plus
 - o an amount equal to the difference between the employee's location allowance and the amount their partial dependant receives in district or location allowance.
- If an employee receives free board and lodging, or is paid an allowance for board and lodging, the rate of location allowance is adjusted to 66.67% (two thirds) of the rate for the relevant town.

Money handling allowance

If an employee is required by the employer to collect money from customers they must be paid \$7.60 per week.

Fares and travelling time

If an employee is required to work outside their usual place of employment during working hours and is not paid the motor vehicle allowance they must be reimbursed for any reasonable travelling expenses incurred.



Meal breaks

- An employee (other than a continuous shift worker) must receive a meal break of between 30 minutes and one hour after no more than six hours of work.
- A continuous shift worker must receive a 20 minute paid break in each shift.



Hours and overtime

Ordinary hours

- An average of 38 hours per week with the hours actually worked being 40 per week or 80 per fortnight to be worked eight hours per day on any five days of the week or ten days of the fortnight.
- Worked with two hours of each week's work accruing as an entitlement to a maximum of 12 Accrued Day(s) Off in each 12 month period.
- Part time and casual employees have a minimum shift length of 3 hours.
- Part time employees work less than 38 hours per week. At the time of engagement the employer and the part time employee will agree, in writing, on a regular pattern of work specifying at least the hours worked each day, which days of the week the employee will work and the actual starting and finishing times each day.
- All time worked in excess of the ordinary hours, including all time worked in excess of the hours mutually agreed upon between the employer and a part time employee, is considered overtime.
- Overtime must be paid for at the rate of time and a half for the first two hours and double time after that.

Different overtime rates and conditions apply to continuous shift employees. View the Cleaners and Caretakers (Car and Caravan Parks) Award on the WA Industrial Relations Commission website www.wairc.wa.gov.au

Shift and weekend work

Hours	Rate
Afternoon shifts commencing between 12 noon and 6.00pm	Additional 15%
Night shifts commencing between 6.00pm and 4.00am	Additional 15%
Ordinary hours worked between midnight on Friday and midnight on Saturday Time and a half	
Ordinary hours worked between midnight on Saturday and midnight on Sunday	Time and three quarters

If weekend/shift rates and overtime are both applicable, the overtime must be paid **in addition** to the weekend or shift rates.



Deductions from pay

An employer may **only** make a deduction from an employee's pay if:

- the employee has agreed to the deduction in writing, (as part of a written employment contract or otherwise) and the deduction is on behalf of the employee;
- the employer is authorised by the WA award to make the deduction and the deduction is on behalf of the employee; or
- the employer is required by a court or a state or federal law to make the deduction (e.g. tax that must be withheld from the employee's pay).



Employment records

- Employers are legally required to keep employment records which demonstrate that employees have been paid all entitlements under the Cleaners and Caretakers (Car and Caravan Parks) Award and relevant legislation.
- Employers must keep all employment records for at least 7 years after they are made for both current and past employees. Records relating to long service leave must be kept for 7 years from the date employment ends.
- Employers can be fined up to \$5,000 by the Industrial Magistrates Court for not keeping employment records or for keeping inadequate or fraudulent records. Employers often fail to keep sufficient detail in their employment records.
- Employers must keep records that detail:
 - Employee's name
 - Date of birth if under 21 years of age
 - o Date employee commenced with the employer
 - Total number of hours worked each week
 - o The gross and net amounts paid to the employee
 - All information required to calculate long service leave entitlements and payment
 - All pay deductions and reasons for them
 - Name of WA award that applies
 - Daily start and finish time and meal breaks taken
 - o Employment status (full time, part time, casual)
 - Employee's classification under the award
 - All leave taken, whether paid, partly paid or unpaid
 - Any other information necessary to prove that the wages received by an employee comply with the requirements of the Cleaners and Caretakers (Car and Caravan Parks) Award, such as overtime hours worked and allowances paid. Contact Wageline or view the full Cleaners and Caretakers (Car and Caravan Parks) Award on the WA Industrial Relations Commission website www.wairc.wa.gov.au for details.
- Employment records can be written or electronic as long as they are in a form that can be printed. Time and wage books can be used to keep employment records, however, it is the employer's responsibility to ensure the time and wage book includes all of the required information.
- The records must be in English.
- Wageline's <u>Employment record obligations for WA award employers</u> publication helps state system employers keep correct employment records. The publication features helpful step by step guides to record keeping and Wageline's new look record keeping templates.



Public holidays

- Full time employees are entitled to public holidays (or days substituted for public holidays) without deduction of pay. Part time employees are entitled to public holidays (or days substituted for public holidays) without deduction of pay if they would ordinarily be required to work on that day if it was not a public holiday.
- If a public holiday falls on a Saturday or Sunday, the following Monday will be considered to be the public holiday. However, if Boxing Day falls on a Sunday or Monday, the following Tuesday will be considered to be the public holiday. When a public holiday is substituted with another day, the public holiday itself is no longer considered a public holiday for the purposes of the WA award.
- When any of the days observed as a holiday under this award falls on a day when an employee is rostered off duty and the employee has not been required to work on that day the employee must be paid as if the day was an ordinary working day, or, if the employee agrees, be allowed a days' leave with pay in lieu of the holiday at a time mutually acceptable to the employer and the employee.
- If an employee works on a public holiday or substituted public holiday they must be paid at the rate of double time and one half, or if they agree paid at time and a half plus an additional days' leave.

This WA award summary covers the basic leave entitlements for employees covered by the Cleaners and Caretakers (Car and Caravan Parks) Award but does **not** include all details on leave obligations and entitlements. Full details of conditions are contained in the Cleaners and Caretakers (Car and Caravan Parks) Award on the WA Industrial Relations Commission website www.wafrc. a.gov.au, the *Minimum Conditions of Employment Act 1993* and the *Long Service Leave Act 1958*.

Bereavement leave

- All employees, including casual employees, are entitled to two days paid bereavement leave on the death of a spouse, de facto partner, parent, step-parent, grandparent, child, step-child, grandchild, sibling or any other member of the employee's household. The two days need not be consecutive.
- Bereavement leave is a minimum entitlement from the Minimum Conditions of Employment Act 1993.

Parental leave

Employees, including eligible casual employees, are entitled to the unpaid parental leave entitlements in the National Employment Standards of the *Fair Work Act 2009*, as well as a number of more beneficial conditions contained in the *Minimum Conditions of Employment Act 1993* (a return to work after parental leave on a modified basis and a reversion to pre-parental leave working conditions). Visit the <u>Parental leave</u> page for more details.

Long service leave

- Long service leave is a paid leave entitlement for employees who have continuous employment with 'one and the same employer' for a specified period. Full time, part time and casual employees are entitled to long service leave under the Long Service Leave Act 1958.
- To be entitled to long service leave an employee's employment with their employer must be continuous. The amount of their long service leave is determined by the employee's period of continuous employment.

- There are a range of paid and unpaid absences or interruptions to an employee's employment that count towards the employee's period of employment for the purposes of accruing long service leave. Some other types of absences do not break an employee's continuous employment, but do not count towards an employee's period of employment for the purposes of accruing long service leave. See the Long service leave What is continuous employment page for more information.
- 'The one and the same employer' also includes employers who previously owned a business, where there has
 been a transmission of business. This means an employer who buys or otherwise acquires a business or part of a
 business will take on the long service leave obligations for existing employees if there has been a transmission of
 business. This applies regardless of anything written in a sale of business contract.

Taking long service leave

The long service leave entitlement for full time, part time and casual employees is:

- after 10 years of continuous employment' with the one and the same employer $-8^{2/3}$ (8.667) weeks of leave on 'ordinary pay'; and
- for every 5 years of continuous employment with the one and the same employer after the initial 10 years $-4^{1/3}$ (4.333) weeks of leave on ordinary pay.

When employment ceases

Employee with between 7 and 10 years of continuous employment When an employee with at least 7 but less than 10 years of continuous employment resigns or is terminated, they are entitled to pro rata long service leave on the basis of $8^{2/3}$ (8.667) weeks for 10 years of continuous employment. This entitlement:

- is calculated on the employee's entire period of employment; that is, years, months, weeks and days;
- applies to employees who resign, are made redundant, die or whose employer has terminated them for any reason other than serious misconduct; and
- does not apply to an employee whose employer has terminated them for serious misconduct.

Employee with 10 or more years of continuous employment

Full entitlement – 10 years or more of continuous employment

An employee who resigns or whose employment is terminated for any reason is entitled to:

- $8^{2/3}$ (8.667) weeks of leave if they have completed 10 years of continuous employment; and
- an additional 4^{1/3} (4.333) weeks of leave for each subsequent 5 years after the initial 10 years of continuous employment.

Pro-rata entitlement – more than 10 years of continuous employment

When an employee with more than 10 years but less than 15 years of continuous employment resigns or is terminated, they are entitled to pro rata leave. This entitlement:

- is calculated on the basis of $8^{2/3}$ weeks for 10 years of continuous employment for each year of employment since they completed 10 years of continuous employment;
- is calculated on completed years of employment only; that is, it does not include months, weeks or days; and
- does not apply to an employee whose employer has terminated them for serious misconduct.

This pro rata entitlement (calculated on the basis of $8^{2/3}$ weeks for 10 years of continuous employment) will also apply to each year of employment since an employee completed 15, 20, 25, 30, 35 years etc. of employment.

- The Long service leave pages of the Wageline website contain extensive information on:
 - What counts as continuous employment, including details on the impact of various types of paid and unpaid absences or interruptions on continuous employment.
 - What happens when business ownership changes.
- The <u>WA long service leave calculator</u> can provide an estimate of an employee's long service leave entitlement when employment ends as a result of resignation, dismissal, death or redundancy. The WA long service leave calculator is available at <u>www.dmirs.wa.gov.au/lslcalculator</u>.

Sick and carer's leave

- Sick and carer's leave entitles a full time or part time employee to paid time off work due to either illness or injury to themselves (sick leave), or because they have to care for an ill or injured family or household member (carer's leave).
- Full time and part time employees are entitled to paid sick and carer's leave equal to the number of hours they would ordinarily work in a two week period, up to 76 hours per year. Sick and carer's leave is a cumulative entitlement, and any leave not taken in one year can be carried over to the next year.
- Sick and carer's leave accrues on a weekly basis for full and part time employees.
- In the first year of employment, a full time or part time employee can use any paid sick and carer's leave that they have accrued to date for caring purposes.
- In the second and subsequent years of employment, a full time employee can only use a maximum of 76 hours of their accrued sick leave entitlement for caring purposes, or a part time employee the relevant proportion of 76 hours based on their ordinary hours of work.
- An employee is entitled to up to two days of unpaid carer's leave per occasion if an employee does not have sufficient paid leave accrued or has exceeded the maximum amount of carer's leave that can be taken in any 12 month period.
- Casual employees are not entitled to paid sick leave or paid carer's leave. Casual employees can access up to two day's unpaid carer's leave per occasion.
- Sick and carer's leave is a minimum entitlement from the Minimum Conditions of Employment Act 1993.
- Wageline's Sick leave calculation guide can assist with calculating sick and carer's leave entitlements.
- Wageline's Employment record obligations for WA award employers publication includes a leave record template.

Annual leave

- Full time employees are entitled to a minimum of four weeks of paid annual leave for each year of completed service, up to 152 hours. Part time employees are entitled to a minimum of four weeks of paid annual leave per year paid on a pro rata basis according to the number of hours they are ordinarily required work in a four week period. Casual employees are not entitled to annual leave.
- Annual leave is a minimum entitlement in the Minimum Conditions of Employment Act 1993 and the Cleaners and Caretakers (Car and Caravan Parks) Award sets out additional requirements regarding annual leave and annual leave loading.
- During a period of annual leave an employee must be paid annual leave loading of 17.5%. If an employee would have received any additional rates for work performed in ordinary hours, had they not been on leave, and such additional rates would have entitled them to a greater amount than the 17.5% loading, then such additional rates must be paid in lieu of the 17.5% loading.
- On termination, annual leave loading of 17.5% is paid out on fully accrued annual leave entitlements for completed years of employment. Annual leave loading is not paid on proportionate leave (leave accrued in an incomplete year of employment) on termination.
- Annual leave accrues on a weekly basis:
 - o A full time employee accrues 2.923 hours of annual leave for each completed week of work.
 - A part time employee accrues the relevant proportion of 2.923 hours annual leave for each completed week
 of work.

Resignation, termination and redundancy

Resignation by the employee

Full time and part time employees are required to provide one week's notice, or if the employee is within the three month probationary period, one day's notice.

Termination

- An employer can terminate the services of a casual employee at any time and all wages due must be paid at the termination of the employment.
- Except in cases of serious misconduct an employer is required to give full time and part time employees the following period of notice of termination (or payment in lieu):

Period of continuous service	Notice period
Not more than 1 year	1 week
More than 1 year but not more than 3 years*	2 weeks
More than 3 years but not more than 5 years*	3 weeks
More than 5 years*	4 weeks

^{*}Employees over 45 years of age with two or more years of continuous service must receive an additional week's notice.

Dismissal requirements

- Under state laws, employees cannot be dismissed if to do so would be harsh, unfair or oppressive. There must be
 a valid and fair reason for dismissal, such as:
 - o consistent unsatisfactory work performance (which has been raised with the employee and the employee given further training and an opportunity to improve their work performance);
 - o inappropriate behaviour or actions; or
 - serious misconduct.
- The <u>Dismissal information</u> page outlines obligations and requirements when an employee is terminated.

Redundancy

- An employee is redundant when their employer has made a definite decision that they no longer wish the job the employee has been doing to be done by anyone.
- When an employee has been made redundant they are entitled to receive:
 - o the appropriate notice period or pay in lieu of notice, as outlined in the Termination section above;
 - o paid leave for job interviews;
 - o any unpaid wages;
 - o any unused accrued and pro rata annual leave
 - any unused accrued long service leave;
 - o pro rata long service leave (if applicable); and
 - severance pay (if applicable).

Severance pay - Employers who employ 15 or more employees

- Employers covered by this award who employ 15 or more employees must pay severance pay when an employee is made redundant, as outlined in the table below.
- Employers who employ less than 15 employees are not required to make severance payments to redundant employees.

2 years and less than 3 years	6 weeks


^{*}An employee's period of continuous service includes any service with that business under a previous employer where there has been a transmission of the business.

- These severance pay requirements do not apply to probationary employees, apprentices and trainees, casual and contract employees or employees terminated due to serious misconduct or for other reasons not related to redundancy.
- Redundancy pay is calculated based on the applicable number of weeks' severance multiplied by ordinary time earnings. Ordinary time earnings excludes overtime, penalty rates, and allowances.
- If the employee resigns during the notice period, they are entitled to the same severance pay they would receive if they had worked until the end of the notice period. However, in this circumstance the employee is not entitled to payment in lieu of notice.

Classifications

- A "Caretaker" is an employee required to reside on or in the vicinity of the premises of the employer, and who is
 responsible to the employer for the supervision and/or the general maintenance of such premises, and for the
 safety of the employer's grounds, building and appurtenances, but shall not mean an employee who is employed
 to manage such premises.
- "Watchperson" is an employee who is required to watch and/or guard and/or patrol grounds and/or buildings.
- "Cleaner" is an employee substantially employed in performing cleaning work.
- "Parking Attendant" is an employee employed in car parks, either indoor or outdoor. Duties shall include the directing of clients' vehicles in such places and where applicable the collection of admission fees to such places.
